Mrs. Ramsey made a motion to continue how we have been doing it and buy the lots back at the purchased price without a deed fee. Mr. Blanton seconded the motion.

Mrs. Ramsey suggest that we table this for the next meeting. She would like to go out see what trees they would be taking down.

- Garage building (Blue one) Needs insulation and lighting. We will need to take down the ceiling tiles to be able to insulate it.
- Maintenance building at the cemetery Mrs. Ramsey suggest a clean up around that building before Memorial Day. Mr. Blanton agreed. There is some stuff there that could be put on GovDeals and other stuff taken to the scrap yard.
