The Salem Township Board of Trustees met on May 26, 2020 in regular session at the Salem Township Fire Station Conference Room for the purpose of transacting the business of the Township. He believes that he is doing it as well with another one that has junk vehicles from last October. He will follow up at the next meeting.
