RESOLUTION PROHIBITING PARKING ON VARIOUS STREETS IN SALEM TOWNSHIP, WARREN COUNTY, OHIO

WHEREAS, the Board of Salem Township Trustees have been advised by the Township's Fire Department and road maintenance employees that parking of automobiles along the curb of various subdivision has impeded the access to property by public safety vehicles and equipment and has impeded the access of the plowing and treatment of snow and ice; and,

WHEREAS, the Board of Salem Township Trustees has determined that the public safety and welfare would be served by regulating certain subdivision streets as a No Parking zone, as such roadway or street is not a state highway; and,

WHEREAS, such a regulation does not conflict with the Uniform Traffic Act, and is applicable only to unincorporated areas of a township, and

WHEREAS, Ohio Revised Code section 505.17 permits a township to enact a regulation creating a no parking zone.

THEREFORE, BE IT RESOLVED by the Board of Trustees of Salem Township, Warren County, Ohio, at least a majority of all Trustees casting a vote concur as follows:

Section 1. Parking on the following township roads or subdivision streets, in Salem Township, Warren County, Ohio, is prohibited. Said roadway shall be designated by the installation of traffic control devices posting No-Parking zone that conforms to Ohio Revised Code Section 4511.09:

- 1. Washington Way
- 2. Traude Court
- 3. Ray Court
- 4. Brook Drive

#### Briarwood:

- 1. Bramblebush Drive
- 2. Thornview Drive

#### Wolf Run:

1. Wolf Run Lane

- 3. Orchard View Lane
- 4. Misty Ridge Court

- Section 2. That this regulation is subject to the limitations, restrictions, and exceptions in sections 4511.01 to 4511.76 and 4513.02 to 4513.37 of the Ohio Revised Code.
- Section 3. That whoever violates this regulation is guilty of a minor misdemeanor. Fines levied and collected under this resolution shall be paid to the Township Fiscal Officer at such time and place as shall be designated on the ticket issued by the ticketing officer. Said monies shall be deposited into the Salem Township general revenue fund.
- Section 4. That the Board of Salem Township Trustees or its designated agent may order into storage any vehicle parked in violation of this regulation if such signage include: a) a statement this is a tow-away zone; b) the telephone number and the address of the place from which a towed vehicle may be recovered at any time during the day or night; and, c) a statement that the failure to recover a towed vehicle may result in the loss of title to the vehicle as provided in ORC 4505.101 (B). The owner or any lienholder of a vehicle ordered into storage may claim the vehicle upon presentation of proof of ownership, which may be evidenced by a certificate of title to the vehicle, and payment of all expenses, charges, and fines incurred as a result of the parking violation and removal and storage of the vehicle.
- Section 5. The Salem Township Fiscal Officer is directed to post these regulations in five conspicuous public places in Salem Township for thirty (30) days and publish the same in a newspaper of general circulation in the Township for three (3) consecutive weeks, after which this regulation shall become immediately effective.

- Section 6. That the Board is acting in its legislative capacity in adopting this Resolution.
- Section 7. That the recitals contained within the Whereas Clauses set forth above are incorporated by reference herein.
- Section 8. That it is found and determined that all formal actions of the Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Board in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Mr. Kilburn moved adoption of the foregoing Resolution, being seconded by Mr. Blanton Upon call of the roll, the following vote resulted:
