Proposed change – new full-time employee to receive ½ of that time at six months and the balance at end of one year. . Mr. Blanton made a motion to approve the proposed change the policy manual for new full-time employees to receive 40 hours vacation and 48 sick time at six months employment and balance at the end of one year.
