Fire Department: Chief Harrison reported:

 Excited to report that we received the Assistance to Firefighters Grant (AFG) from the US Department of Homeland Security in the amount of \$198,560.95 with a 5% matching funds of \$9,928.05 for a total approved budget of \$208,489.00 for new equipment. The trustees thanked Chief Harrison for all his hard work and time in applying for these grants. Mr. Blanton made a motion to accept the AFG in the total amount of \$208,489.00 Mr. Kilburn seconded the motion.

- Presented July Monthly Report runs are down a little form last month.
- Warren County purchased a new CAD (Computer Aided Dispatch). They have been working on this for more than five years. This will help dispatching and tracking units headed to the scene. It will help get Fire, EMS, and Law Enforcement to incidents faster.
- New Phone system being installed this week. Should be up and running soon. We will be cutting several lines from Century Link, which will help us cut cost.
- Reminder Fire Levey Renewal 3.9 mil on November 3rd Ballot. NO TAX INCREASE!
- Presented a 5 minute video courtesy of Tri-health of the story of Diane Fisher and her heart attack. Chief Harrison said he could not be more proud of his dedicated staff. They are always learning and this story shows just how that pays off. The Trustees could not agree more. Mr. Blanton said this hits to close to home from his own personal experience from having a heart attack. Mrs. Ramsey agreed from her mother's experience and the way the crew responded to her. Mr. Kilburn stated "Everyone loves a Fireman". Everyone agreed.

Zoning: Zoning Inspector Mike Yetter reported:

- Regarding the Trustees giving Mr. Leitner 60 days this will be notice as his final notice and he will have to have this done or it will go to the courts. Mr. Leinter said he understood and again thanked the trustees for the extra time.
