The Salem Township Board of Trustees met on September 8, 2020 in regular session at the Salem Township Fire Station Conference Room for the purpose of transacting the business of the Township. Trustee Susan Ramsey called the meeting to order at 7:00pm with Trustee Ralph Blanton and Trustee Heath Kilburn present. Mrs. Ramsey led all those present in the pledge to the flag.

**Others present:** Greg Gatman, Bob Glancy, Adger Thomann and Rob States

- Mr. Gatman asked if a few signs on his road could be updated, they are in bad shape. Mr. Blanton said that he will take a look at them.
- Mr. Adger Thomann, property owner at 4321 Thornview Dr. of Briarwood Subdivision stopped by the meeting to drop off a hard drive that has pictures of their roads in their subdivision. He asked the board to take a look at them and see when they can be fixed. Mr. Kilburn asked him to stay for the meeting. He said he couldn't he was headed to work. Mrs. Ramsey said that they will look at the pictures.
- Mr. Rob States, property owner at 3407 Gray Fox Tr of Laskeside Subdivision attended tonight's meeting to discuss street repairs. Mr. Blanton explained that the Township has 24 miles of roadway and the cost is about \$100,000 a mile. Mr. Kilburn noted that we have roads that are gravel and have not been paved. Mr. States said that he understood what they were talking about, but he asked if there is another way of getting it done rather than prioritizing. It's been 24 years since his road has been paved and it sounds like it will a while before it gets done again. He explained that he is a concerned citizen and that he is here asking what he can do to help the community and get this done in a more timely manner. Mr. Blanton explained that it's all a matter of money and that the township doesn't have the funds to do more than what we have been doing. In 2020 we have spent around \$190,000.00. He explained that it doesn't cost as much to do chip and seal, but that too has to have repairs and maintenance done to it. Mr. States asked if the Trustees would be open to a Levy for roads like Hamilton Township? Mrs. Ramsey said that Salem Township is a rural area and we don't have the businesses like Hamilton Township has. There are a lot of elderly in our township and she believes it would be a hard levy to pass. The other trustees agreed. Mr. States asked if there could be a Road assessment figured like the light assessments for the Township to recoup some of the funds to keep investing them in to the roads. Mrs. Ramsey said she did not know that as well as the other trustees said they did not know that as well. Mr. States told the trustees that he is here to help. He asked for a copy of the Township budget. Mr. Blanton thanked him for coming to the meeting and again stressed that the trustees manage what we have with what budget we have. We are rural and we are doing the best we can by prioritizing. Mr. Blanton said that he will e-mail Mr. States the 2020 Township budget.
