Mr. Nice reported that there is not currently a noise regulation for the township. There can be one put into place, however there are limits to what can be done. Example there are exemption to the regulation such as, Agriculture use and events on agriculture properties.

The trustees heard from several guest from tonight's meeting, speaking for and against the noise regulation. The Trustees chose to have open discussion on the decision to adopt a noise ordinance or not.

Mrs. Ramsey made a motion to not adopt a noise reregulation at this time. She just doesn't see where it will help with the current or future issues due to the agriculture exemption. Mr. Kilburn second the motion in total agreement.
