## Zoning - Donald Lynch property

Donald Lynch was present to check on the status of the information from ODOT regarding the fence he wants to construct around his property. Richard had a copy of a letter that Christine Hilbert at ODOT had sent to Mr. Lynch explaining the regulations that must be followed to meet Ohio Revised Code. In the letter it states that the right of way along his frontage is 33 feet from the centerline of US 22. They asked him to either remove the fence posts that he has already installed, or hire a licensed surveyor to determine the exact location of the right-of-way along US 22. There was a brief discussion with Mr. Lynch trying to work out the logistics of what he can and cannot do with the fence. He still wants to get a permit for the fence and put it up. He stated it would be temporary. He is trying to get the bus running and will sell it then. He said he has gotten rid of 30-40% of the "stuff" for which he was cited. Lee Short mentioned that the fence code reads that a fence cannot be over 6 ft. high or less than 4 ft. Lee also told him if he doesn't agree with that, he could go to the zoning board of appeals to ask for a higher limit.

The trustees told him he would be able to put up a 6 ft fence as long as it's out of the ODOT dictated right-of-way. They questioned him as to why he would want to put up a 6 ft fence that would not hide some of his junk and he would still be in violation. It would not solve his problem. He stated he wanted to sell as much as possible and cut back on the business.

#### Zoning Office

Richard reported he had inspected the Miracle building last Thursday. There are no rides in the building, only a truck and some miscellaneous items. Mr. Miracle would still like to put equipment in the barn, but he is looking for another place to store his equipment.

Richard has received a complaint about the property at 2290 St. Rt. 123. He said that now all vehicles except for one have been removed. Rob Glancy suggested to Richard that when someone is in violation, he needs to move forward with the process rather than giving them chance after chance to clean up their property. It was mentioned that in the case where there are renters on a property, the citation would go to the property owner.

# Catholic Cemetery Transfer

The cemetery transfer was brought up. Debbie sent a letter to the Archdiocese that the prosecutor's office drafted, but has not received a reply yet.

#### Roads

Fred reported that he received a check from an insurance company for Duke Energy towards the damages on Waynesville Road. The check was in the amount of \$3,950.00.

The condition of Trovillo Road was discussed. Fred stated he was afraid the hillside is sliding down. Jeff Jones is supposed to look at it. Currently there is a big bump in the road and the hillside does keep moving down. It was decided that the crew could put black top on both sides of the bump for now. It was mentioned that the road might have to become one-way.

## Fire Department

Fred turned in the resignation of part time paid employee Dustin Bierley. He is planning on returning to school full time. Dick Kilburn made a motion to accept the resignation from Dustin Bierley. Rob Glancy seconded the motion.
