Fire Department

Chief Harrison reported there was a firefighter rescue practice at Kings Elementary today held in conjunction with the sheriff's office rescue task force. Attending along with some of his men were Deerfield Twp., Clearcreek Twp., and Franklin city.

He has one bid for the protective equipment that would include vest and triage bags. It is from Vance Law Enforcement, a state bid, and is approximately \$7,000 for the 8 sets plus \$1000 for the triage bags. He wants to look for another price. They will continue training with the sheriff's office using their equipment. He would like to purchase this equipment as soon as he finds the best price.

Heath Kilburn made a motion to approve \$8,000.00 for the purchase of protective equipment for the firemen/EMS when the best price is found. Susan Ramsey seconded the motion.

Time Clocks

Ralph Blanton brought up the fact that since Chief LaFollette retired, there hasn't been a way to keep track of the time worked by the temporary summer employees. He said he thought it was time to put time clocks in the township building and at the cemetery. Chief Harrison has done some research and has found three systems that would operate by fingerprint recognition. All three were priced around \$500.00. At this time there was a fire run and Chief and FF Principato had to leave.

On his way out, he did report he had received word that the bulletin board had been shipped.

Heath Kilburn made a motion to purchase two (2) time clocks spending up to \$1,100.00. Susan Ramsey seconded the motion.

Donald Lynch mentioned the fact that the township had no internet postings and no notifications on the website.

It was reported that the two trees on Trovillo Road that had come down had been cleaned up and gotten off the road.

At the last meeting the idea of having a day to drop off used tires had been brought up. However, at the recent tire collecting event at the Village, over 600 tires had been turned in which was way more than they expected. That created quite a job to get rid of them.

The food pantry building tested ok for the mold and can now be put to use again.

## Salt Bid

The county's salt bidding process was complete and the low bid was from Detroit Salt Company at \$53.40 per ton. The township had ordered 100 tons. Heath Kilburn made a motion to accept the bid received by the county. Susan Ramsey seconded the motion.
