The Salem Township Board of Trustees met February 12, 2019 in regular session at the Salem Morrow Fire Station Conference Room for the purpose of transacting the business of the Township. President Ralph Blanton called the meeting to order at 7:00 P.M. with members Heath Kilburn and Susan Ramsey present. Mr. Blanton led all those present in the pledge to the flag.

The trustees read the minutes from the January 8, 2019 meeting and Susan Ramsey made a motion to approvethese minutes. Heath Kilburn seconded the motion.Vote:Mrs. Ramsey, yeaMr. Kilburn, yeaMr. Blanton, yea

Rob States, a resident on Grey Fox Tr. in the Lakeside Park development, reported drainage issues in the area around his residence.

Courtney Temple was present as part of the requirements to apply for the Warren County Township Association's annual scholarship.

Gary Painter asked about the township's meeting agendas and meeting dates. He also asked about the increase in his water bill, but was informed that the bill comes from the Village of Morrow.

Regarding the work to be done on Gheils Carroll Road, Mr. Blanton reported that only one bid was received. It was from Freeze Underground in the amount of \$26,350. He checked with the prosecutor's office and was told it would be ok to accept the bid even though it was the only one. Heath Kilburn made a motion to accept the bid from Freeze Underground in the amount of \$26,350 for the culvert and road repair on Gheils Carroll Road; motion was seconded by Susan Ramsey. Vote: Mr. Kilburn, yea Mrs. Ramsey, yea Mr. Blanton, yea Mr. Blanton added that Jeff Freeze had done a job for the township a few years ago, and the work was excellent.

Mr. Blanton brought up the fact that townships are now required to have an approved Credit Card Policy. He submitted a policy that was prepared by the Warren County Prosecutor's office. The township currently has 3 credit cards; one for the Fiscal Office, one for Trustees and one for the Fire Department. Mr. Kilburn made a motion to pass *Resolution 2019-0212A to update the Credit Card Policy for Salem Township.* Mrs. Ramsey seconded the motion. Vote: Mr. Kilburn, yea Mrs. Ramsey, yea Mr. Blanton, yea

Mr. Kilburn then mad a motion to pass **Resolution 2019-0212B** to name Ralph Blanton, Deborah Harper and William Harrison as authorized users of the Township Credit Cards. Mrs. Ramsey seconded the motion.

The county sent out notice that they were putting together the salt bid for the winter of 2019-2020. Susan Ramsey made a motion that the township should take part in the county salt purchase with 300 tons being the amount to purchase. Heath Kilburn seconded the motion. The county is also working on the summer paving projects. Ralph Blanton mentioned the Gheils Carroll hill, but the township needs to wait to see what the final cost of the culvert project will be before a commitment for this year's paving is made. It was mentioned that the township could do some chip sealing this year with the crew and

Heath Kilburn mentioned the pot holes on Lake and Salem Roads. The crew has been out checking the roads for pot holes.

Mr. Kilburn also stated he thought the crew should be more proactive as far as checking culverts so they can be fixed before they become a bigger job.

Ghiels Carroll road is washing out on the right hand side and the culverts are all plugged.

Susan Ramsey mentioned that maybe there is a need for another full time employee to help get some of these jobs done.

It was mentioned that there are junk cars at Ward Road and also on St Rt 123. These need to be moved.

There was no zoning updates for this meeting.
