Ralph Blanton mentioned that there are at least 10 trees on the right hand side that need to come down. He had a quote from Flint's Tree Service for \$400 per tree. He will try to get another price.

The Food Pantry workers have asked if they could have a window installed in the room where the freezers are kept. After a brief discussion, all the trustees were in agreement to let them do this. They will pay for the freezer and have it installed.

Heath Kilburn brought up a cemetery question. Greg Webb had mentioned about the possibility of allowing up to five cremations on one grave site, and have one head stone with the common name on it. This matter was discussed and it was mentioned that you could possibly get 8 cremations on one grave site.
