The trustees read the minutes from the November 26, 2019 meeting and Susan Ramsey made a motion to approve these minutes. Ralph Blanton seconded the motion.

Chief Harrison then reported he had interviewed Mitchell Fisher to be added to the volunteer roster. SusanRamsey made a motion to accept Mitchell Fisher as a volunteer; seconded by Heath Kilburn.Vote:Mrs. Ramsey, yeaMr. Kilburn, yeaMr. Blanton, yea

Next, Chief Harrison brought before the board three applicants' names who have applied for fuul time positions. They need to pass one of the required tests yet, but he would like to have it approved to offer them the full time position pending those tests results. Susan Ramsey made a motion to approve the hiring in a full time position Darrick Treat, James Montgomery and John French; seconded by Heath Kilburn. He reported there were three heart attack runs yesterday with no fatalities. Also there was a large barn fire on Wilmington Road that required several departments to put that fire out. Also there were six of our firemen who went on the baby non-breather run. He has offered two meetings with them to be sure they were doing ok with this wrenching experience. He felt like they were handling it ok.

Ralph Blanton then explained to Don Lynch that he had done some research in the ORC meeting rules. He told Mr. Lynch that we would be following ORC procedures and allow him three minutes to speak. Mr. Lynch replied by stating he didn't think he was unruly at the meeting. He then brought up the proposed contract with the Warren County Regional Planning Commission for help in getting the zoning code updated and in line with what is needed in the township. He felt it was not a good contract for the township.

It was then brought up that the next scheduled meeting would fall on December 24, Christmas Eve. It was decided that meeting would be help on Monday, December 23<sup>rd</sup> instead.

Ralph Blanton then brought up the matter of the proposed contract and recommendations from the WC Regional Planning Commission and stated that he didn't think they would get anyone outside the county to do the job and who knew the township for that price. After a brief discussion, Heath Kilburn made a motion to approve the contract in the amount of \$8,000 with the Warren County Regional Planning Commission to lead the township in revising and updating the current code. Motion seconded by Susan Ramsey. Vote: Mr. Kilburn, yea Mrs. Ramsey, yea Mr. Blanton, yea

Trustee Ramsey brought up the matter of the property on the corner of Ward Road and 22-3. She said it was an awful mess and they needed to do something about it. Trustee Blanton said he would check with the prosecutor on the matter.

Mrs. Ramsey also brought up an issue regarding keeping in touch with what the crew has been doing. She suggested that at least once a month they should attend the meeting and give a report of what they had been working on. After again suggesting they be required to attend the meetings, Ralph Blanton said he disagreed on that suggestion since he acts as their supervisor and they check in all the time with him. But he said that if the board felt like it was needed, he would agree with it.

Mr. Kilburn said he had wanted to check on the log they keep a few years back, but it was never done. He thinks it would be helpful to know what is being worked on. He will work on getting a log book set up to keep track of what work is being done.

Chief Harrison stated he has a daily log sheet that the firemen use. He thinks it would work for the township employees as well.

Ralph Blanton brought up that the contract for the PUCO license needs to be renewed to allow the township to continue its electric aggregation program It was a 2 year contract. Susan Ramsey made a motion to renew the contract with the Public Utilities Commission of Ohio for another 2 years to continue the township's electric aggregation program; seconded by Heath Kilburn.

Mr. Blanton reported that he had asked Chuck Petty if he had anything going out for bids that could include the 5 (five) culvert replacements needed on Gheils Carroll Road. Heath Kilburn added that he thought there was a need for another culvert on that road in the area that was recently repaired.

Mr. Blanton added that they needed to get a list to the county for the 2020 paving projects. It was discussed that paving the entire length of Gheils Carroll Road would be necessary. They will also look into all the culverts.

A letter was received from a resident on Misty Meadows concerning a swell in the road. Trustee Blanton has looked at it and is not sure anything needs to be done. They need to keep an eye on it and see if it needs to be built up.
